

Take-back of old products B2B in accordance with ElektroG3

TAKE-BACK CONCEPT FOR WASTE ELECTRICAL AND ELECTRONIC EQUIPMENT (WEEE)

(Status: 25.07.2023)

The EU Directive 2012/19/EU on Waste Electrical and Electronic Equipment (WEEE) and the German Electrical and Electronic Equipment Act (ElektroG) require manufacturers of electrical and electronic equipment to provide a reasonable opportunity for the return of waste equipment for users other than private households - so-called B2B equipment.

In accordance with EU Directive 2002/96/EC of the European Parliament and of the EU Council on Waste Electrical and Electronic Equipment (WEEE) and the new version of the EU Directive, 2012/19/EU, there is an obligation to collect, treat and dispose of waste electrical and electronic equipment in accordance with regulations. According to the Electrical and Electronic Equipment Act (ElektroG) applicable in Germany, every manufacturer is obliged to create a reasonable opportunity to take back waste electrical and electronic equipment from users other than private households.

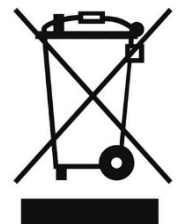
K-TECH Electronic Vertriebs GmbH takes responsibility for its products and recycles them after use. We have provided return and disposal solutions for old machines (old electrical appliances) purchased from K-TECH that have been used commercially or in public facilities - so-called B2B devices. We carry the costs for the processing, recycling and recovery of the machines we produce. In return, our customers bear the costs for transport to our plant in Nördlingen.

Personal responsibility for the deletion/disposal of personal data

According to § 19a ElektroG we are obliged to the following information: We expressly point out that all personal data/information on the machines (waste electrical equipment) to be disposed of must be deleted by you.

Meaning of the symbol for marking electrical equipment

- Items in our product range that fall under the Electrical and Electronic Equipment Act (ElektroG) are marked with the crossed-out wheeled garbage can symbol. A product marked accordingly must be collected separately at the end of its useful life and returned to the intended recycling cycle.
- If the machines contain batteries, the batteries must be removed before returning the machine.



Possibility to return old machines

You would like to dispose of an electrical appliance purchased from K-TECH Electronic Vertriebs GmbH correctly. Please contact us by telephone or e-mail and request an RMA number (return authorization number).

In addition, the following requirements must be considered for the proper processing of your return shipment:

Returns must be registered in advance and must be marked "Return for scrapping in accordance with the WEEE Directive".

- When registering a return, item-specific information of the type and quantity of items to be returned must be provided.
- A return must be marked with the RMA number (return number) and the reason for return on the delivery bill.
- The RMA number is clearly visible attached on the packaging.
- Items that are sent to us without prior notification cannot be processed and will be returned to the sender.
- The sender has to carry the shipping costs, therefore only carriage paid deliveries are accepted.
